Subsequent citations of the same source are usually abbreviated, often using the author's last name, a shortened title, and the page number. For instance:

- 2. Foucault, *Discipline and Punish*, 45.

If citing the same source immediately after the previous note, "Ibid." (Latin for "in the same place") can be used, followed by the page number if different. If it's the exact same page, "Ibid." alone suffices. For example:

- 3. Ibid., 50.
- 4. Ibid.

The Bibliography

At the end of the research paper, a Bibliography is included. This section provides a comprehensive, alphabetized list of all the sources cited in the notes. The format of entries in the Bibliography is similar to that of the first note, but there are subtle differences, primarily in punctuation and the arrangement of author names (last name first for the first author, then first name first for subsequent authors).

An example of a book entry in a Chicago-style bibliography:

- Foucault, Michel. *Discipline and Punish: The Birth of the Prison*. Translated by Alan Sheridan. New York: Vintage Books, 1977.

Author-Date System

The Author-Date system is more commonly used in the social sciences and sciences. It utilizes brief parenthetical citations within the text, consisting of the author's last name and the year of publication, and a corresponding reference list at the end of the paper.

In-Text Citations: Author-Date

In the Author-Date system, citations are placed parenthetically within the text, typically at the end of a sentence or clause where the information is introduced. The parenthetical citation includes the author's last name and the year of publication. If a specific page or range of pages is being referenced, it is also included.

For example:

- (Foucault 1977, 17)

If the author's name is mentioned in the text, only the year of publication and page number (if applicable) need to be included in the parentheses:

- Foucault (1977) argues that the prison system evolved significantly in the 18th century (17).

When multiple works by the same author in the same year are cited, they are distinguished by adding lowercase letters (a, b, c, etc.) to the year, both in the text and in the reference list. For example: (Foucault 1977a) and (Foucault 1977b).

The Reference List

The Reference List in the Author-Date system is an alphabetized compilation of all the sources cited in the text. Unlike the Bibliography in the Notes system, it is arranged by the author's last name and includes the year of publication immediately after the author's name. This makes it easier for readers to quickly locate the source by year.

An example of a book entry in a Chicago-style Author-Date reference list:

Key Formatting Elements in Chicago Style

footnotes and endnotes is often a matter of personal preference or publisher guidelines.

Footnotes are generally preferred for standalone papers, as they allow readers to see the citation immediately. Endnotes can be useful in longer works or when the notes would otherwise disrupt the flow of the text on the page. Each note is numbered sequentially throughout the paper.

The Bibliography

Whether you are using the Notes and Bibliography system or the Author-Date system, a comprehensive list of cited sources is essential.
