Understanding the Two Chicago Style Systems

The Chicago Manual of Style (CMOS) offers two primary citation systems, each serving different needs within academic disciplines. For social science publications, particularly in psychology, both the Notes-Bibliography system and the Author-Date system are widely accepted, though one might be preferred by specific journals or institutions. Understanding the fundamental differences and applications of each is the first step towards mastering Chicago style for your psychological research.

The Notes-Bibliography System in Psychology

The Notes-Bibliography system is characterized by the use of superscript Arabic numerals within the text to indicate a citation. These numbers correspond to footnotes or endnotes, which contain the full bibliographic information for the source. A bibliography, or reference list, is also included at the end of the work, listing all cited sources alphabetically. This system is often favored in disciplines that require extensive commentary or dialogue with sources, allowing for detailed explanations alongside the citation.

In psychological research, the Notes-Bibliography system can be particularly useful when discussing theoretical underpinnings or historical developments that require extensive contextualization. The Author-Date system is often preferred in psychology because it quickly allows readers to identify the temporal context of the research being discussed, which is vital in a field that rapidly builds upon prior findings. It also streamlines the in-text referencing process, making it less intrusive to the narrative of the paper.

Citing Journal Articles in Psychology

Journal articles are a cornerstone of psychological research, and their accurate citation is essential. Both Chicago style systems provide specific formats for citing these vital sources, ensuring that readers can easily locate the original work.

Notes-Bibliography System for Journal Articles

When using the Notes-Bibliography system, a superscript number in the text directs the reader to a footnote or endnote. The note typically includes the author's full name, the article title (in quotation marks), the journal title

(in italics), the volume and issue numbers, the year of publication, and the page number(s) of the article. The corresponding bibliography entry omits the page range for the article itself but includes it if the source is a chapter or section.

For example, a footnote might appear as:

The bibliography entry would be:

Author-Date System for Journal Articles

In the Author-Date system, the in-text citation is concise, typically including the author's last name and the year of publication. For direct quotes or specific paraphrasing, the page number is also included. The reference list at the end of the paper provides the full details.

An in-text citation would look like:

(Doe 2021, 112)

The reference list entry would be:

- Doe, Jane. 2021. "The Impact of Cognitive Behavioral Therapy on Anxiety Disorders." *Journal of Clinical Psychology* 45 (3): 110–25.

Note the slight difference in punctuation and date placement compared to the Notes-Bibliography system.

Citing Books and Book Chapters in Psychology

Books and their constituent chapters are fundamental resources in psychology, covering foundational theories, comprehensive reviews, and empirical studies. Proper citation ensures academic integrity and guides readers to these valuable resources.

Notes-Bibliography System for Books and Chapters

For a full book using the Notes-Bibliography system, the footnote or endnote would include the author's full name, the book title (in italics), and the publication details: place of publication, publisher, and year. For a specific chapter within an edited book, the note would also include the chapter title (in quotation marks) and the editor's name(s).

Example for a book:

- 2. John Smith, *Foundations of Social Psychology* (New York: Oxford University Press, 2019).

Example for a chapter:

The corresponding bibliography entries would follow a similar structure but omit specific page numbers unless referencing a direct quote from a chapter.

Author-Date System for Books and Chapters

The Author-Date system offers a more streamlined in-text citation for books and chapters. The parenthetical citation includes the author and year. Page numbers are appended for direct quotes or specific references.

In-text citation for a book:

(Smith 2019, 78)

In-text citation for a chapter:

(White 2020, 55)

The reference list entry for a book typically includes the author's name, year of publication, title (in italics), and publication details. For a chapter, it includes the author of the chapter, year, chapter title (in quotation marks), editor(s), book title (in italics), and publication details, including page range for the chapter.

- Smith, John. 2019. *Foundations of Social Psychology*. New York: Oxford University Press.
- White, Emily. 2020. "Cognitive Biases in Decision Making." In *Handbook of Cognitive Psychology*, edited by Robert Green, 50–75. London: Sage Publications.

Citing Dissertations and Theses in Psychology

Dissertations and theses represent original research and are important sources in academic discourse. Chicago style provides clear guidelines for citing these unpublished or recently published works.

Notes-Bibliography System for Dissertations and Theses

When citing a dissertation or thesis, the notes would include the author's name, the title of the work (in italics), the type of degree (e.g., PhD dissertation, Master's thesis), the university, and the year of completion. If the work has been published or is available through a database, that information should also be included.

Example note:

- 4. David Brown, *Attachment Styles and Interpersonal Relationships* (PhD diss., University of California, Berkeley, 2022).

The bibliography entry would be similar, with a slight adjustment in punctuation and potentially the inclusion of an access date if retrieved online.

Author-Date System for Dissertations and Theses

The Author-Date system's in-text citation for dissertations and theses mirrors that of other works, typically the author and year. The reference list entry is crucial for providing full details.

In-text citation example:

(Brown 2022)

The reference list entry would be:

- Brown, David. 2022. *Attachment Styles and Interpersonal Relationships*. PhD diss., University of California, Berkeley.

If the dissertation is accessible online, such as through ProQuest, this should be noted in the reference entry, including the database name and accession number or URL.

Citing Online Resources and Electronic Media

In contemporary psychology, a significant portion of research and data is accessed online. Chicago style offers detailed instructions for citing a wide array of digital resources, ensuring that these sources are properly attributed.

Notes-Bibliography System for Online Resources

For online articles, websites, or other digital content, the Notes-Bibliography system requires the author (if available), the title of the specific page or article (in quotation marks), the website name (in italics), the publication or last updated date, and the URL. Crucially, the date of access should also be included.

Example note:

The bibliography entry will be structured similarly, ensuring all necessary retrieval information is present.

Author-Date System for Online Resources

The Author-Date system requires an in-text citation with the author and year. If no author is listed, the first few words of the title may be used. The reference list entry is vital for providing complete access details.

In-text citation example (if author is available):

(Lee 2023)

Reference list entry example:

- Lee, Sarah. 2023. "Understanding Confirmation Bias." *Psychology Today*. Last modified March 15, 2023. Accessed October 26, 2023. <https://www.psychologytoday.com/confirmation-bias-understanding>.

For resources without a clear publication date, use "(n.d.)" for "no date." It's important to be as precise as possible with dates and URLs.

Formatting Tables and Figures

The clear and consistent presentation of data through tables and figures is crucial in psychological research. Chicago style provides specific guidance on their formatting, numbering, and titling to enhance readability and professionalism.

Tables

Tables should be numbered consecutively (Table 1, Table 2, etc.) and each should have a clear, descriptive title placed above it. The table itself should be logically organized with clear headings for columns and rows. Any explanatory notes or abbreviations used within the table should be defined below it, often as a legend or footnote.

The content of the table should be concise, focusing on presenting raw data, statistical results, or summaries of findings. Ensure that all data presented in the table is also discussed or referenced in the main text of the publication.

Figures

Figures, which include graphs, charts, diagrams, and images, are also numbered consecutively (Figure 1, Figure 2, etc.). The figure caption, which includes the number and a descriptive title, is typically placed below the figure. Similar to tables, figures should be self-explanatory, with all elements clearly labeled. Legends for symbols or line types should be incorporated directly into the figure or its caption.

It is essential that figures are of high resolution and are easily reproducible. When referring to a figure in the text, use the figure number, for example, "As shown in Figure 3, participant response times increased significantly..."

Common Pitfalls and Best Practices
