- **Interviews:** For unpublished interviews, include the interviewee's name, the type of interview (e.g., "personal interview," "email interview"), the date conducted, and the location if applicable. Example: Smith, Jane. Personal interview. March 15, 2023. Chicago, IL.

Tables, Figures, and Appendices

In addition to citations, Chicago style for social sciences dissertations also dictates the presentation of supplementary materials such as tables, figures, and appendices.
