If multiple works by the same author in the same year are cited, they are distinguished by adding lowercase letters to the year (e.g., 2020a, 2020b).

When the author's name is mentioned in the text, it does not need to be repeated in the parenthetical citation. For example: As Giddens argues, structuration theory posits that ... (1984). This system prioritizes brevity within the narrative flow of the sociological argument.

The Reference List (Author-Date System)

In contrast, the author-date system concludes with a reference list. This list includes only the sources that were cited within the text of the manuscript. Like the bibliography, it is arranged alphabetically by the author's last name. However, the formatting of each entry differs slightly from the notes-bibliography system, with the year of publication often appearing immediately after the author's name.

A book entry in an author-date reference list would be formatted as: Smith, John. 2018. *Theories of Social Stratification*. Chicago: University of Chicago Press.

A journal article entry would be: Johnson, Sarah. 2020. "The Evolution of Urban Communities." *American Sociological Review* 85 (3): 456-478.

The distinction between a bibliography and a reference list is crucial for proper adherence to Chicago style.
