Chicago style, also known as the Chicago Manual of Style (CMOS), is a widely adopted citation and style guide in academic and professional writing. This system allows for extensive explanatory notes or commentary alongside the citation, offering a richer engagement with the source material.

The Author-Date System

The Author-Date system, which shares similarities with APA and MLA styles, is more common in the social sciences and natural sciences. In this system, brief in-text citations are placed directly within the text, typically following the author's last name and the publication year, enclosed in parentheses. For example, a citation might appear as (Smith 2020, 45). This brief citation directs the reader to a corresponding entry in a reference list at the end of the essay. The reference list contains full bibliographic details for all sources cited in the text. This system prioritizes conciseness in the text, allowing for a more streamlined reading experience while still providing complete source attribution.

In-Text Citations in Chicago Style

The method of in-text citation in Chicago style is directly determined by which of the two systems you are employing. Whether using footnotes/endnotes or parenthetical author-date citations, the goal is to clearly and efficiently point the reader to the source of information. Proper in-text citation is paramount for avoiding plagiarism and giving credit to original authors.

Notes and Bibliography System: Footnotes and Endnotes

In the Notes and Bibliography system, in-text citations are indicated by superscript numbers placed at the end of a sentence or clause, immediately after punctuation. For instance: "The study revealed significant findings (1)." If a direct quote is used, the superscript number typically follows the closing quotation mark: "As reported by the researchers, 'the results were conclusive' (2)." These superscript numbers correspond to either footnotes at the bottom of the page or endnotes at the conclusion of the essay. The first time a source is cited, the note will contain full bibliographic information. Subsequent citations of the same source can use a shortened form, usually including the author's last name, a shortened title, and the page number.

Author-Date System: Parenthetical Citations

The Author-Date system uses parenthetical citations directly within the text. These citations typically include the author's last name and the year of publication. For example: (Johnson 2021). If a specific page or range of pages is being referenced, it should be included after the year, separated by a comma: (Johnson 2021, 112). When quoting directly, page numbers are essential: (Johnson 2021, 112). If citing an online source without page numbers, the paragraph number may be used, or a shortened title if no author is provided: (Short Title of Work).

Footnotes and Endnotes: The Notes and Bibliography System

Footnotes and endnotes are the distinguishing features of the Notes and Bibliography system in Chicago style. They serve as the primary mechanism for directing readers to specific sources and, in some cases, for providing additional commentary or elaboration that might disrupt the flow of the main text. Mastering the formatting of these notes is essential for students using this system.

Formatting Footnotes

Footnotes appear at the bottom of the page where the citation is made. Each footnote begins with a superscript number that matches the corresponding number in the text. The first line of a footnote is indented, and subsequent lines are usually aligned to the left margin. The format of the footnote closely mirrors that of the bibliography entry but often includes more specific page numbers. For a book, a typical first footnote might look like this: Jane Doe, *The Art of Research* (New York: Academic Press, 2019), 78.

Formatting Endnotes

Endnotes are gathered together at the end of the document, preceding the bibliography. They are organized sequentially, with each endnote corresponding to a superscript number in the text. The formatting of endnotes is identical to that of footnotes. The primary difference is their location. Some instructors prefer endnotes as they can make the main body of the essay appear cleaner and less interrupted by citation details. The first note for a book cited in endnotes would be formatted similarly to the footnote example: Jane Doe, *The Art of Research* (New York: Academic Press, 2019), 78.

The Bibliography: Compiling Your Sources

Regardless of whether you use the Notes and Bibliography system or the Author-Date system, a comprehensive list of all sources consulted and cited in your essay is required. This list, whether called a Bibliography or a Reference List, is a critical component of your academic work. It allows readers to locate the original sources and provides a complete overview of the research conducted.

Bibliography Formatting

The Bibliography is typically placed at the very end of the essay. It is organized alphabetically by the author's last name. Each entry provides full bibliographic details for a source. Unlike footnotes or endnotes, the first line of a bibliography entry is usually flush with the left margin, and subsequent lines are indented (hanging indent). This formatting makes it easier to scan the list and locate specific authors. For example, a book entry might appear as:

- Doe, Jane. *The Art of Research*. New York: Academic Press, 2019.

A journal article entry would include the journal title, volume, issue, and page numbers:

- Smith, John. "New Discoveries in Astrophysics." *Journal of Cosmic Studies* 15, no. 2

(2020): 201-225.

Reference List vs. Bibliography

While often used interchangeably, in Chicago style, there's a subtle distinction. A **Bibliography** lists all sources consulted, whether cited in the text or not. A **Reference List**, used with the Author-Date system, only includes sources that have been directly cited in the essay. For student essays, it is crucial to clarify with your instructor whether they require a full bibliography or a reference list.

The Author-Date system presents a different approach to source attribution within Chicago style, prioritizing brevity in the main text and directing readers to a comprehensive reference list. This method is often preferred in disciplines where the currency of research and the rapid dissemination of findings are paramount.

Integrating Author-Date Citations

As discussed, author-date citations are embedded directly within the prose. They are non-intrusive, allowing the reader to follow the narrative flow of the essay while still being aware of the source of information. The parenthetical citation typically includes the author's last name and the year of publication. Books

Journal Articles

Citing journal articles requires specific details. For the Notes and Bibliography system, a footnote/endnote might appear as:

- 2. Sarah Lee, "Pedagogical Innovations in STEM Education," *Journal of Educational Research* 45, no. 3 (2022): 310.

The bibliography entry would be:

- Lee, Sarah. "Pedagogical Innovations in STEM Education." *Journal of Educational Research* 45, no. 3 (2022): 305-320.

The Author-Date in-text citation would be (Lee 2022, 310), with the reference list entry matching the bibliography entry.

Websites and Online Sources

Citing online sources can be challenging due to their varying structures. Key information includes the author (if available), title of the specific page or article, name of the website, publication or last updated date, and the URL. For the Notes and Bibliography system:

For the Author-Date system, the in-text citation might be (EdTech Hub), and the reference list entry would mirror the bibliography entry but may omit the access date if not crucial.

Incorrect Page Number Referencing
