Understanding Citation Styles in Chicago

The Chicago Manual of Style (CMOS) offers two primary citation systems: the author-date system and the notes-bibliography system. Both are widely accepted in academia, but their application can vary depending on the specific journal, institution, or discipline within environmental research.

Understanding the nuances of each system is the first step towards effective and compliant scholarly writing.

The Author-Date System

The author-date system is characterized by brief parenthetical citations within the text that include the author's last name and the year of publication. Each note provides a full citation the first time a source is referenced, and subsequent notes for the same source can be shortened.

The bibliography at the end of the document functions similarly to the reference list in the author-date system, presenting all cited sources in alphabetical order by author's last name. The primary advantage of the notes-bibliography system is its ability to incorporate extensive explanatory notes or digressions without interrupting the flow of the main text, which can be useful for discussing complex environmental methodologies or historical context.
