The Two Chicago Style Citation Systems

Author-Date System: In-Text Citations Explained

The author-date system provides a more concise in-text citation method by embedding brief references directly within the prose. This system requires a parenthetical note that typically includes the author's last name and the year of publication. The page number is often included as well, especially when quoting directly or referencing specific information.

These parenthetical citations serve as immediate signposts for the reader, directing them to the corresponding full entry in the reference list, which is located at the end of the document.
