Full Reference List Entries for Journals

The reference list in the Author-Date system is similar to the bibliography in the Notes-Bibliography

system but omits the publication date from the initial parenthetical citation in the text. The core elements of the journal article citation remain consistent: author's name (reversed), article title, journal title, volume, issue, publication date, and page numbers, often including a DOI or URL. The reference list is strictly alphabetical.

The format for a journal article in the reference list is:

- Author's Last Name, First Name. Year. "Article Title." *Journal Title* Volume, no. Issue (Publication Date): Page Numbers.
