## Understanding Chicago Style Citation Systems

The Chicago Manual of Style (CMOS) is renowned for its flexibility, offering two primary citation systems: the notes-bibliography system and the author-date system. ## Citing Online Journals in Notes

information about its online accessibility. If a DOI is available, it is preferred and should be included. If no DOI is present, a stable URL should be provided. The format generally follows: Author, "Article Title," Journal Title Volume, no. Issue (Year): Page(s), DOI or URL.

For instance: 2. John Smith, "Digital Humanities and Literary Studies," *Digital Scholarship Quarterly* 10, no. 1 (2023): 45-60, <https://doi.org/10.1080/12345678.2023.987654>.

If a DOI is not available, the citation might appear as: 3. Emily White, "The Impact of Social Media on Political Discourse," *Communications Studies Review* 30, no. 2 (2021): 88-105, <https://www.examplejournal.com/article/12345>.

## **The Author-Date System for Journals**

The author-date system, often used in scientific and social science disciplines, provides a more concise in-text citation. This system emphasizes the author and the year of publication, allowing readers to quickly identify the source in the reference list. The in-text citations are brief parenthetical references, directing the reader to the full bibliographic details provided at the end of the paper.

## **The Reference List for Author-Date**

The reference list in the author-date system serves the same purpose as the bibliography in the notes-bibliography system: it provides full bibliographic details for every source cited in the text. The list is alphabetized by the author's last name and is titled "References." Each entry includes specific details about the publication, allowing readers to locate the original sources.

### **Citing Print Journals in the Reference List**

When citing print journal articles in the reference list of an author-date paper, the format is slightly different from the notes system, particularly in the order of elements and punctuation. The author's last name comes first, followed by their first name. The article title is usually not italicized or placed in quotation marks. The journal title, volume, issue, year, and page numbers are then presented in a specific order.

The standard format is: Author, Last Name, First Name. Year. "Article Title." *Journal Title* Volume (Issue): Page Range.

For example: Doe, Jane. 2022. "The Evolution of Scientific Thought." *Journal of Academic Research* 25 (3): 110-125.

## Citing Online Journals in the Reference List

For online journal articles in the author-date system, the inclusion of a DOI or URL is crucial for retrieval. Similar to print journal citations, the author's last name is listed first, followed by the first name. The article title is presented without quotation marks. The journal title is italicized, followed by the volume, issue, year, and page range. The DOI or URL is appended at the end.

A typical entry with a DOI would be: Smith, John. 2023. "Digital Humanities and Literary Studies." *Digital Scholarship Quarterly* 10 (1): 45-60. <https://doi.org/10.1080/12345678.2023.987654>.

If no DOI is available, a stable URL should be used: White, Emily. 2021. "The Impact of Social Media on Political Discourse." *Communications Studies Review* 30 (2): 88-105. <https://www.examplejournal.com/article/12345>.

This might involve adding "Special Issue" or similar phrasing after the journal title or in the notes. The editor(s) of the special issue might also be included in the citation, particularly if they are central to the publication's identity.

## Using DOIs and URLs Correctly

Digital Object Identifiers (DOIs) are permanent links that help readers access journal articles online. When a DOI is available, it should always be used in citations as it is more reliable than a regular URL, which can change. Chicago style provides specific formatting for DOIs, usually presented as a hyperlink. If no DOI is available, a stable URL is the next best option.
