SUMMARIZING MAIN POINTS AND FINDINGS

A CONCISE SUMMARY OF THE KEY ARGUMENTS AND FINDINGS IS ESSENTIAL. THIS IS NOT A MERE REPETITION OF EVERY DETAIL, BUT RATHER A DISTILLATION OF THE MOST IMPACTFUL POINTS THAT SUPPORTED YOUR THESIS. OFFERING A FINAL THOUGHT OR CALL TO ACTION (WHEN APPROPRIATE)

DEPENDING ON THE NATURE OF YOUR PAPER, YOU MIGHT CONCLUDE WITH A POWERFUL FINAL THOUGHT THAT LEAVES THE READER WITH SOMETHING TO PONDER. THIS COULD BE A LINGERING QUESTION, A PREDICTION, OR A SUBTLE SUGGESTION FOR FURTHER INVESTIGATION. FOR SOME TYPES OF ACADEMIC WORK, A CALL TO ACTION, FRAMED WITHIN SCHOLARLY DISCOURSE, MIGHT BE APPROPRIATE, ENCOURAGING FURTHER ENGAGEMENT WITH THE TOPIC.

WHAT TO AVOID IN YOUR CHICAGO STYLE PAPER ENDING

DOING SO CAN CONFUSE THE READER AND UNDERMINE THE COHERENCE OF YOUR RESEARCH. ALL SIGNIFICANT POINTS SHOULD HAVE BEEN DEVELOPED AND SUPPORTED WITHIN THE MAIN TEXT.

APOLOGIZING OR UNDERMINING YOUR WORK

PHRASES LIKE "I MAY NOT HAVE COVERED EVERYTHING" OR "THIS IS JUST MY OPINION" WEAKEN YOUR STANCE. A PROFESSIONAL CHICAGO STYLE PAPER ENDING SHOULD CONVEY CONFIDENCE IN YOUR RESEARCH AND ANALYSIS. PRESENT YOUR FINDINGS WITH AUTHORITY, BASED ON THE EVIDENCE YOU HAVE METICULOUSLY GATHERED AND PRESENTED.

BEING TOO VAGUE OR GENERIC

A CONCLUSION THAT IS TOO GENERAL OR LACKS SPECIFICITY CAN LEAVE THE READER UNSATISFIED. WHILE YOU ARE LOOKING AT BROADER IMPLICATIONS, ENSURE THESE ARE STILL TIED DIRECTLY TO THE SPECIFIC RESEARCH YOU HAVE CONDUCTED. AVOID Clichés OR PLATITUDES THAT DO NOT ADD SUBSTANTIAL MEANING TO YOUR ARGUMENT.

SIMPLY REPEATING YOUR INTRODUCTION VERBATIM

AS MENTIONED EARLIER, REHASHING YOUR INTRODUCTION WITHOUT ALTERATION IS UNPRODUCTIVE. THE CONCLUSION SHOULD REFLECT THE GROWTH AND DEVELOPMENT OF YOUR ARGUMENT. A SIMPLE REPETITION SIGNALS A LACK OF SYNTHESIS AND UNDERSTANDING OF THE CONCLUDING FUNCTION.

THE ROLE OF THE BIBLIOGRAPHY IN THE CHICAGO STYLE PAPER

WHILE NOT STRICTLY PART OF THE NARRATIVE ENDING, THE BIBLIOGRAPHY IS AN INDISPENSABLE COMPONENT OF ANY CHICAGO STYLE PAPER, PROVIDING THE FINAL TESTAMENT TO THE SCHOLARLY FOUNDATIONS OF YOUR WORK. NOTES AND BIBLIOGRAPHY SYSTEM

IN THIS SYSTEM, FOOTNOTES OR ENDNOTES ARE USED TO CITE SOURCES WITHIN THE TEXT, AND A COMPREHENSIVE BIBLIOGRAPHY APPEARS AT THE END OF THE PAPER. THE BIBLIOGRAPHY IS TYPICALLY ORGANIZED ALPHABETICALLY BY THE AUTHOR'S LAST NAME. IT INCLUDES FULL BIBLIOGRAPHIC INFORMATION FOR EACH SOURCE, ALLOWING READERS TO LOCATE AND VERIFY THE INFORMATION YOU HAVE USED.

AUTHOR-DATE SYSTEM

THE AUTHOR-DATE SYSTEM USES PARENTHETICAL IN-TEXT CITATIONS (E.G., (AUTHOR YEAR, PAGE)) AND IS ALSO ACCOMPANIED BY A REFERENCE LIST AT THE END OF THE PAPER, ORGANIZED ALPHABETICALLY. THIS LIST PROVIDES THE NECESSARY DETAILS FOR EACH CITED SOURCE.

REGARDLESS OF THE CHOSEN SYSTEM, THE BIBLIOGRAPHY (OR REFERENCE LIST) IS CRUCIAL FOR ACADEMIC HONESTY AND FOR ENABLING FURTHER RESEARCH BY YOUR READERS. IT DEMONSTRATES THE BREADTH AND DEPTH OF YOUR RESEARCH AND ACKNOWLEDGES THE WORK OF OTHERS. IT IS THE FINAL, CONCRETE MANIFESTATION OF YOUR SCHOLARLY ENGAGEMENT WITH THE TOPIC.

TIPS FOR CRAFTING A MEMORABLE CHICAGO STYLE PAPER ENDING

- **CONSIDER YOUR AUDIENCE:** TAILOR THE COMPLEXITY AND SCOPE OF YOUR CONCLUDING THOUGHTS TO THE INTENDED AUDIENCE OF YOUR PAPER. FOR ACADEMIC JOURNALS, THIS MIGHT INVOLVE MORE TECHNICAL IMPLICATIONS; FOR A BROADER READERSHIP, IT MIGHT BE MORE GENERAL RELEVANCE.

- **READ ALOUD:** READING YOUR CONCLUSION ALOUD CAN HELP YOU IDENTIFY AWKWARD PHRASING, REPETITIVE SENTENCES, OR AREAS WHERE THE FLOW COULD BE IMPROVED. THIS PRACTICE IS INVALUABLE FOR POLISHING ANY PIECE OF WRITING.

Q: IS IT ACCEPTABLE TO OFFER A PERSONAL OPINION IN MY CHICAGO STYLE PAPER ENDING?

A: GENERALLY, NO. ACADEMIC PAPERS, ESPECIALLY IN CHICAGO STYLE, EMPHASIZE OBJECTIVE ANALYSIS. WHILE YOU CAN DISCUSS THE SIGNIFICANCE OF YOUR FINDINGS, FRAME IT THROUGH SCHOLARLY INTERPRETATION RATHER THAN PERSONAL BELIEF.
