THE PURPOSE AND IMPORTANCE OF A CHICAGO STYLE PREFACE IN INTERNATIONAL RELATIONS

THE PREFACE IN AN ACADEMIC WORK WITHIN INTERNATIONAL RELATIONS TRANSCENDS MERE FORMALITY; IT IS A STRATEGIC TOOL FOR ACADEMIC COMMUNICATION. FOR SCHOLARS ENGAGING WITH COMPLEX GLOBAL ISSUES, DIPLOMACY, CONFLICT, AND

COOPERATION, THE PREFACE PROVIDES AN ESSENTIAL ROADMAP FOR THE READER. IT ALLOWS THE AUTHOR TO FRAME THE ENSUING DISCUSSION, HIGHLIGHTING THE SPECIFIC QUESTIONS THAT DRIVE THE RESEARCH AND THE THEORETICAL OR EMPIRICAL CONTRIBUTIONS THE WORK AIMS TO MAKE. IN A DISCIPLINE CHARACTERIZED BY DIVERSE THEORETICAL PERSPECTIVES AND INTERDISCIPLINARY APPROACHES, A CLEAR PREFACE IS VITAL FOR SITUATING THE RESEARCH WITHIN ESTABLISHED DEBATES AND IDENTIFYING ITS NOVEL ASPECTS. IT ACTS AS A BRIDGE BETWEEN THE AUTHOR'S INTELLECTUAL ENDEAVOR AND THE READER'S COMPREHENSION, FOSTERING A DEEPER APPRECIATION FOR THE WORK'S SIGNIFICANCE.

MOREOVER, A CHICAGO-STYLE PREFACE IN INTERNATIONAL RELATIONS SCHOLARLY WORKS IS A DELIBERATE CHOICE THAT SIGNALS ADHERENCE TO ESTABLISHED ACADEMIC NORMS AND EDITORIAL STANDARDS. IT DEMONSTRATES A COMMITMENT TO TRANSPARENCY IN RESEARCH, PARTICULARLY CONCERNING THE INTELLECTUAL JOURNEY AND THE SUPPORT SYSTEMS THAT FACILITATED ITS COMPLETION. THIS SECTION IS WHERE AN AUTHOR CAN OFFER A PERSONAL YET PROFESSIONAL GLIMPSE INTO THE GENESIS OF THEIR IDEAS, THE CHALLENGES ENCOUNTERED, AND THE EVOLUTION OF THEIR THINKING. FOR READERS UNFAMILIAR WITH THE SPECIFIC SUBFIELD OR THEORETICAL FRAMEWORK BEING EMPLOYED, THE PREFACE CAN DEMYSTIFY COMPLEX CONCEPTS AND PROVIDE ESSENTIAL BACKGROUND CONTEXT, THEREBY ENHANCING ACCESSIBILITY AND ENGAGEMENT WITH THE MATERIAL.

KEY COMPONENTS OF A CHICAGO STYLE PREFACE

A WELL-STRUCTURED PREFACE FOR A WORK IN INTERNATIONAL RELATIONS, ADHERING TO CHICAGO STYLE GUIDELINES, TYPICALLY INCLUDES SEVERAL DISTINCT BUT INTERCONNECTED ELEMENTS. THESE COMPONENTS WORK IN CONCERT TO PROVIDE A COMPREHENSIVE OVERVIEW OF THE BOOK OR ARTICLE'S CONTEXT, INTENT, AND INTELLECTUAL UNDERPINNINGS. UNDERSTANDING EACH PART IS CRUCIAL FOR AUTHORS TO EFFECTIVELY COMMUNICATE THEIR SCHOLARLY PROJECT TO THE ACADEMIC COMMUNITY AND BEYOND.

ACKNOWLEDGEMENT OF INTELLECTUAL DEBT AND INFLUENCES

WITHIN THE PREFACE, AUTHORS IN INTERNATIONAL RELATIONS OFTEN ACKNOWLEDGE THE SCHOLARS AND SEMINAL WORKS THAT HAVE SHAPED THEIR THINKING. THIS IS NOT SIMPLY A MATTER OF COURTESY BUT A CRUCIAL ACT OF INTELLECTUAL ACCOUNTABILITY. BY REFERENCING KEY THEORISTS, EMPIRICAL STUDIES, OR HISTORICAL ANALYSES, THE AUTHOR SITUATES THEIR OWN WORK WITHIN THE ONGOING SCHOLARLY CONVERSATION. THIS SECTION CAN HIGHLIGHT THE INTELLECTUAL LINEAGE OF THEIR RESEARCH, DEMONSTRATING HOW THEIR IDEAS HAVE BEEN INFORMED BY, OR ARE IN DIALOGUE WITH, PREVIOUS CONTRIBUTIONS TO THE FIELD OF INTERNATIONAL RELATIONS. IT HELPS READERS UNDERSTAND THE THEORETICAL FRAMEWORK AND THE ESTABLISHED LITERATURE THAT FORMS THE FOUNDATION UPON WHICH THE CURRENT RESEARCH IS BUILT, OFFERING CONTEXT FOR THE AUTHOR'S ARGUMENTS AND CONCLUSIONS.

STATEMENT OF PURPOSE AND SCOPE

A CENTRAL FUNCTION OF THE PREFACE IS TO CLEARLY ARTICULATE THE BOOK'S OR ARTICLE'S PRIMARY PURPOSE AND ITS DEFINED SCOPE. FOR INTERNATIONAL RELATIONS SCHOLARSHIP, THIS MEANS SPECIFYING THE CENTRAL RESEARCH QUESTION(S) BEING ADDRESSED, THE GEOGRAPHICAL OR THEMATIC BOUNDARIES OF THE STUDY, AND THE HISTORICAL PERIOD UNDER EXAMINATION. FOR EXAMPLE, AN AUTHOR MIGHT STATE THEIR INTENTION TO ANALYZE THE EVOLVING NATURE OF MULTILATERAL SECURITY COOPERATION IN POST-COLD WAR EUROPE OR TO INVESTIGATE THE IMPACT OF EMERGING TECHNOLOGIES ON STATE SOVEREIGNTY. THIS CLARITY HELPS MANAGE READER EXPECTATIONS AND ENSURES THAT THE WORK IS UNDERSTOOD WITHIN ITS INTENDED PARAMETERS, PREVENTING MISINTERPRETATIONS ABOUT ITS COMPREHENSIVENESS OR FOCUS.

METHODOLOGICAL CONSIDERATIONS

IN INTERNATIONAL RELATIONS, THE METHODOLOGY EMPLOYED IS OFTEN A CRITICAL ASPECT OF A STUDY'S CREDIBILITY. THE PREFACE OFFERS AN OPPORTUNITY TO BRIEFLY OUTLINE THE RESEARCH METHODS USED, WHETHER QUALITATIVE, QUANTITATIVE, HISTORICAL, OR THEORETICAL. WHILE DETAILED METHODOLOGICAL DISCUSSIONS BELONG IN THE MAIN BODY OF THE TEXT, A

PREFACE CAN PROVIDE A HIGH-LEVEL OVERVIEW, INDICATING THE APPROACH TAKEN AND WHY IT WAS DEEMED MOST APPROPRIATE FOR ADDRESSING THE RESEARCH QUESTIONS. FOR INSTANCE, AN AUTHOR MIGHT MENTION THE USE OF COMPARATIVE CASE STUDIES, STATISTICAL ANALYSIS OF CONFLICT DATA, OR EXTENSIVE ARCHIVAL RESEARCH TO EXPLORE DIPLOMATIC NEGOTIATIONS. THIS TRANSPARENCY ALLOWS READERS TO ASSESS THE RESEARCH DESIGN AND UNDERSTAND THE BASIS OF THE AUTHOR'S FINDINGS.

TARGET AUDIENCE AND CONTRIBUTIONS

AUTHORS ARE ENCOURAGED TO SPECIFY THE INTENDED AUDIENCE FOR THEIR WORK. IN INTERNATIONAL RELATIONS, THIS COULD RANGE FROM FELLOW SPECIALISTS IN A PARTICULAR SUBFIELD (E.G., INTERNATIONAL POLITICAL ECONOMY, SECURITY STUDIES) TO POLICYMAKERS, GRADUATE STUDENTS, OR EVEN A BROADER EDUCATED READERSHIP INTERESTED IN GLOBAL AFFAIRS. CRUCIALLY, THE PREFACE SHOULD ALSO ARTICULATE THE UNIQUE CONTRIBUTION THE WORK MAKES TO THE EXISTING BODY OF KNOWLEDGE. THIS INVOLVES HIGHLIGHTING WHAT NEW INSIGHTS, DATA, THEORETICAL ADVANCEMENTS, OR POLICY RECOMMENDATIONS THE RESEARCH OFFERS, THEREBY DEMONSTRATING ITS SCHOLARLY VALUE AND RELEVANCE TO THE FIELD OF INTERNATIONAL RELATIONS AND POTENTIALLY TO PRACTICAL POLICY DEBATES.

ACKNOWLEDGEMENTS OF SUPPORT AND ASSISTANCE

A SIGNIFICANT PORTION OF MANY PREFACES IS DEDICATED TO ACKNOWLEDGING THE INDIVIDUALS, INSTITUTIONS, AND FUNDING BODIES THAT HAVE SUPPORTED THE RESEARCH AND WRITING PROCESS. FOR SCHOLARS IN INTERNATIONAL RELATIONS, THIS CAN INCLUDE THANKING RESEARCH ASSISTANTS FOR THEIR DILIGENT WORK, COLLEAGUES FOR THEIR FEEDBACK AND INTELLECTUAL SPARRING, EDITORS AND PUBLISHERS FOR THEIR GUIDANCE, AND FUNDING AGENCIES FOR THEIR FINANCIAL SUPPORT. THESE ACKNOWLEDGEMENTS NOT ONLY DEMONSTRATE GRATITUDE BUT ALSO LEND CREDIBILITY TO THE RESEARCH BY SHOWING THE NETWORK OF SCHOLARLY AND INSTITUTIONAL BACKING IT RECEIVED. CRAFTING THE NARRATIVE: TONE AND STYLE

THE TONE OF A CHICAGO STYLE PREFACE IN INTERNATIONAL RELATIONS SHOULD STRIKE A BALANCE BETWEEN ACADEMIC PROFESSIONALISM AND ENGAGING NARRATIVE. IT SHOULD BE AUTHORITATIVE, DEMONSTRATING A DEEP UNDERSTANDING OF THE SUBJECT MATTER, YET ACCESSIBLE ENOUGH TO DRAW READERS INTO THE INTELLECTUAL JOURNEY. WHILE ADHERING TO FORMAL ACADEMIC CONVENTIONS, THE AUTHOR CAN INJECT A DEGREE OF PERSONAL REFLECTION ABOUT THE RESEARCH PROCESS, THE INSPIRATIONS BEHIND THE STUDY, AND THE INTELLECTUAL EVOLUTION THAT LED TO THE FINAL WORK. THIS APPROACH CAN MAKE THE PREFACE MORE COMPELLING AND HELP ESTABLISH A CONNECTION WITH THE READER, ENCOURAGING THEM TO DELVE DEEPER INTO THE TEXT. CLARITY, CONCISENESS, AND A LOGICAL FLOW ARE PARAMOUNT, ENSURING THAT THE PREFACE EFFECTIVELY COMMUNICATES ITS MULTIFACETED PURPOSE WITHOUT OVERWHELMING THE READER WITH UNNECESSARY DETAIL OR JARGON.

THE STYLE SHOULD REFLECT THE AUTHOR'S VOICE WHILE REMAINING CONSISTENT WITH THE SCHOLARLY EXPECTATIONS OF THE DISCIPLINE. AVOID OVERLY CASUAL LANGUAGE OR COLLOQUIALISMS, BUT ALSO STEER CLEAR OF EXCESSIVE ACADEMIC POMPOSITY. THE GOAL IS TO BE INFORMATIVE AND INVITING, SETTING A TONE THAT IS BOTH RIGOROUS AND APPROACHABLE. FOR INTERNATIONAL RELATIONS, WHICH OFTEN DEALS WITH COMPLEX GEOPOLITICAL AND ECONOMIC ISSUES, THE PREFACE SHOULD AIM TO DEMYSTIFY THE SUBJECT MATTER WHERE APPROPRIATE, OFFERING A CLEAR ENTRY POINT FOR READERS WHO MAY NOT BE EXPERTS IN THE SPECIFIC NICHE BEING EXPLORED. THE NARRATIVE SHOULD GUIDE THE READER FROM THE GENERAL CONTEXT OF THE RESEARCH TO ITS SPECIFIC CONTRIBUTIONS, BUILDING ANTICIPATION FOR THE SUBSTANTIVE CONTENT THAT FOLLOWS.

COMMON PITFALLS TO AVOID IN INTERNATIONAL RELATIONS PREFACES

SCHOLARS WRITING PREFACES FOR INTERNATIONAL RELATIONS WORKS CAN FALL INTO SEVERAL COMMON TRAPS THAT DETRACT FROM THEIR EFFECTIVENESS. ONE FREQUENT ISSUE IS THE TENDENCY TO OVERLY SUMMARIZE THE ENTIRE BOOK'S ARGUMENT OR KEY FINDINGS, WHICH ENCROACHES ON THE ROLE OF THE INTRODUCTION OR CONCLUSION AND CAN REDUCE READER ENGAGEMENT. ANOTHER PITFALL IS THE EXCESSIVE USE OF TECHNICAL JARGON WITHOUT ADEQUATE EXPLANATION, WHICH CAN ALIENATE READERS WHO ARE NOT DEEPLY FAMILIAR WITH THE AUTHOR'S SPECIFIC SUBFIELD. ADDITIONALLY, PREFACES CAN BECOME TOO PERSONAL OR ANECDOTAL, LOSING THEIR ACADEMIC FOCUS, OR CONVERSELY, THEY CAN BE TOO DRY AND UNINSPIRED, FAILING TO CAPTURE THE READER'S INTEREST.

ANOTHER AREA WHERE AUTHORS OFTEN STUMBLE IS IN THEIR ACKNOWLEDGEMENT SECTION. WHILE IT'S IMPORTANT TO THANK INDIVIDUALS AND INSTITUTIONS, LENGTHY AND OVERLY DETAILED LISTS CAN BECOME TEDIOUS. IT IS CRUCIAL TO BE JUDICIOUS AND SPECIFIC IN THE ACKNOWLEDGEMENTS, HIGHLIGHTING THOSE WHO MADE TRULY SIGNIFICANT CONTRIBUTIONS. FURTHERMORE, FAILING TO CLEARLY ARTICULATE THE BOOK'S UNIQUE CONTRIBUTION OR ITS RELEVANCE TO CONTEMPORARY DEBATES IN INTERNATIONAL RELATIONS CAN LEAVE READERS QUESTIONING ITS VALUE. FINALLY, NEGLECTING TO DEFINE THE SCOPE AND LIMITATIONS OF THE RESEARCH CAN LEAD TO MISUNDERSTANDINGS ABOUT WHAT THE WORK AIMS TO ACHIEVE. A PREFACE SHOULD PROVIDE A FOCUSED AND PURPOSEFUL OVERVIEW, NOT AN EXHAUSTIVE ACCOUNT OR A PERSONAL MEMOIR.

THE PREFACE IN THE CONTEXT OF CHICAGO STYLE DOCUMENTATION

WHILE THE PREFACE ITSELF IS A NARRATIVE SECTION AND DOES NOT TYPICALLY EMPLOY THE EXTENSIVE FOOTNOTE OR ENDNOTE CITATION SYSTEM CHARACTERISTIC OF CHICAGO STYLE FOR THE MAIN TEXT, ITS EXISTENCE AND FUNCTION ARE INTEGRAL TO THE OVERALL SCHOLARLY APPARATUS DICTATED BY THE CHICAGO MANUAL OF STYLE. THE PREFACE ESTABLISHES THE INTELLECTUAL GROUNDWORK AND CONTEXT THAT THE SUBSEQUENT NOTES AND BIBLIOGRAPHY WILL THEN RIGOROUSLY DOCUMENT. THE CHICAGO MANUAL OF STYLE OFFERS GUIDELINES ON THE PLACEMENT AND GENERAL CONTENT OF PREFACES AND ACKNOWLEDGEMENTS, EMPHASIZING CLARITY AND ADHERENCE TO ACADEMIC CONVENTIONS. AUTHORS ARE EXPECTED TO USE THE PREFACE TO FRAME THE NARRATIVE AND INTELLECTUAL JOURNEY OF THEIR WORK, SETTING THE STAGE FOR THE DETAILED EVIDENCE AND ARGUMENTATION THAT WILL BE PRESENTED AND CITED THROUGHOUT THE MAIN BODY OF THE TEXT. THEREFORE, UNDERSTANDING THE STYLISTIC EXPECTATIONS FOR A PREFACE IS A COMPLEMENTARY ASPECT OF MASTERING CHICAGO STYLE DOCUMENTATION FOR SCHOLARLY PUBLICATIONS IN INTERNATIONAL RELATIONS.

THE PREFACE, BY ITS NATURE, IS A META-COMMENTARY ON THE SCHOLARLY WORK THAT FOLLOWS. IT EXPLAINS THE 'WHY' AND 'HOW' OF THE RESEARCH, THEREBY PROVIDING A FRAME OF REFERENCE FOR THE READER AS THEY ENGAGE WITH THE DATA, ANALYSIS, AND ARGUMENTS SUPPORTED BY CHICAGO-STYLE CITATIONS. WHILE FORMAL CITATIONS ARE NOT THE PRIMARY FEATURE OF THE PREFACE ITSELF, THE UNDERLYING PRINCIPLE OF TRANSPARENCY AND INTELLECTUAL HONESTY THAT CHICAGO STYLE PROMOTES IS DEEPLY EMBEDDED IN THE PREFACE'S PURPOSE. IT IS WITHIN THIS INTRODUCTORY SPACE THAT THE AUTHOR CAN ETHICALLY AND EFFECTIVELY SET THE INTELLECTUAL LANDSCAPE, ACKNOWLEDGING INFLUENCES AND FOUNDATIONAL IDEAS THAT WILL BE FURTHER ELABORATED AND RIGOROUSLY CITED LATER IN THE WORK, ADHERING TO THE RIGOROUS CITATION STANDARDS OF THE CHICAGO MANUAL OF STYLE.

EXAMPLES AND BEST PRACTICES FOR INTERNATIONAL RELATIONS

EFFECTIVE PREFACES FOR INTERNATIONAL RELATIONS SCHOLARSHIP OFTEN BEGIN WITH A COMPELLING ANECDOTE OR A CONCISE STATEMENT OF A PRESSING GLOBAL CHALLENGE THAT THE RESEARCH ADDRESSES. FOR INSTANCE, A PREFACE MIGHT OPEN BY REFERENCING A RECENT INTERNATIONAL CRISIS TO UNDERScore THE URGENCY AND RELEVANCE OF THE TOPIC. FOLLOWING THIS, A CLEAR STATEMENT OF THE RESEARCH QUESTION, OFTEN FRAMED AS A PUZZLE OR A GAP IN EXISTING LITERATURE, SETS THE INTELLECTUAL DIRECTION. AUTHORS SHOULD THEN BRIEFLY OUTLINE THEIR THEORETICAL APPROACH AND METHODOLOGY, OFFERING JUST ENOUGH DETAIL TO INFORM THE READER WITHOUT BECOMING OVERLY TECHNICAL. THE STATEMENT OF THE BOOK'S CONTRIBUTION SHOULD BE CONFIDENT AND PRECISE, HIGHLIGHTING ITS NOVELTY AND SIGNIFICANCE TO THE FIELD OF INTERNATIONAL RELATIONS AND POTENTIALLY TO POLICYMAKERS OR PRACTITIONERS.

WHEN ACKNOWLEDGING INFLUENCES, SCHOLARS MIGHT REFERENCE SPECIFIC THEORISTS WHOSE WORK PROVIDES A CONCEPTUAL FRAMEWORK OR EMPIRICAL STUDIES THAT HAVE SHAPED THEIR UNDERSTANDING OF A PHENOMENON. IN TERMS OF SUPPORT, IT'S BEST PRACTICE TO THANK INSTITUTIONS AND FUNDING BODIES, FOLLOWED BY KEY COLLEAGUES WHO OFFERED CRITICAL FEEDBACK OR INTELLECTUAL ENGAGEMENT. FOR A PREFACE AIMING FOR BROAD APPEAL IN INTERNATIONAL RELATIONS, CLARITY AND A NARRATIVE THAT FLOWS LOGICALLY ARE PARAMOUNT. CONSIDER THE EXAMPLE OF A BOOK ON THE ETHICS OF HUMANITARIAN INTERVENTION; THE PREFACE MIGHT START WITH THE MORAL DILEMMAS POSED BY INACTION IN MASS ATROCITIES,

THEN INTRODUCE THE THEORETICAL DEBATES SURROUNDING INTERVENTION, OUTLINE THE CASE STUDIES EXAMINED, AND CONCLUDE BY STATING THE BOOK'S CONTRIBUTION TO ETHICAL FRAMEWORKS FOR STATE ACTION IN INTERNATIONAL AFFAIRS. THE OVERALL IMPRESSION SHOULD BE ONE OF SCHOLARLY AUTHORITY, INTELLECTUAL CURIOSITY, AND CLEAR COMMUNICATION OF THE WORK'S PURPOSE AND IMPACT.

A: THE PRIMARY FUNCTION OF A CHICAGO STYLE PREFACE FOR INTERNATIONAL RELATIONS RESEARCH IS TO INTRODUCE THE WORK TO THE READER BY PROVIDING CONTEXT, OUTLINING THE AUTHOR'S INTENTIONS, ARTICULATING THE RESEARCH'S PURPOSE AND SCOPE, ACKNOWLEDGING INTELLECTUAL INFLUENCES AND SUPPORT, AND HIGHLIGHTING THE WORK'S UNIQUE CONTRIBUTION TO THE FIELD.

Q: SHOULD I INCLUDE DETAILED METHODOLOGICAL DESCRIPTIONS IN MY PREFACE FOR AN INTERNATIONAL RELATIONS BOOK?

A: NO, DETAILED METHODOLOGICAL DESCRIPTIONS ARE GENERALLY NOT INCLUDED IN THE PREFACE. INSTEAD, YOU SHOULD PROVIDE A BRIEF, HIGH-LEVEL OVERVIEW OF THE RESEARCH METHODS EMPLOYED AND JUSTIFY THEIR SUITABILITY FOR ADDRESSING YOUR RESEARCH QUESTIONS IN INTERNATIONAL RELATIONS.

Q: HOW DO I ACKNOWLEDGE INTELLECTUAL INFLUENCES IN MY INTERNATIONAL RELATIONS PREFACE?

A: IN YOUR INTERNATIONAL RELATIONS PREFACE, YOU SHOULD ACKNOWLEDGE THE SCHOLARS, THEORIES, OR SEMINAL WORKS THAT HAVE SIGNIFICANTLY SHAPED YOUR THINKING. THIS DEMONSTRATES YOUR ENGAGEMENT WITH THE EXISTING LITERATURE AND SITUATES YOUR RESEARCH WITHIN THE BROADER ACADEMIC DISCOURSE.

Q: WHAT IS THE RECOMMENDED TONE FOR A CHICAGO STYLE PREFACE IN INTERNATIONAL RELATIONS?

A: THE RECOMMENDED TONE FOR A CHICAGO STYLE PREFACE IN INTERNATIONAL RELATIONS IS PROFESSIONAL, AUTHORITATIVE, AND ENGAGING. IT SHOULD BE ACCESSIBLE TO THE INTENDED AUDIENCE WHILE MAINTAINING ACADEMIC RIGOR, BALANCING PERSONAL REFLECTION ON THE RESEARCH JOURNEY WITH SCHOLARLY OBJECTIVITY.

Q: HOW DO I BEST ARTICULATE THE UNIQUE CONTRIBUTION OF MY INTERNATIONAL RELATIONS RESEARCH IN THE PREFACE?

A: TO ARTICULATE THE UNIQUE CONTRIBUTION, CLEARLY STATE WHAT NEW INSIGHTS, DATA, THEORETICAL ADVANCEMENTS, OR POLICY RECOMMENDATIONS YOUR WORK OFFERS TO THE FIELD OF INTERNATIONAL RELATIONS. HIGHLIGHT HOW YOUR RESEARCH FILLS A GAP IN EXISTING KNOWLEDGE OR OFFERS A NOVEL PERSPECTIVE ON ESTABLISHED ISSUES.

Q: IS IT ACCEPTABLE TO USE PERSONAL ANECDOTES IN AN INTERNATIONAL RELATIONS PREFACE?

A: YES, IT CAN BE ACCEPTABLE TO USE BRIEF, RELEVANT PERSONAL ANECDOTES IF THEY EFFECTIVELY INTRODUCE THE RESEARCH TOPIC OR ILLUSTRATE THE GENESIS OF YOUR INTELLECTUAL INTEREST IN INTERNATIONAL RELATIONS. HOWEVER, THESE SHOULD

BE USED SPARINGLY AND ALWAYS SERVE THE ACADEMIC PURPOSE OF THE PREFACE, NOT DOMINATE IT.

Q: WHO SHOULD I ACKNOWLEDGE IN THE PREFACE FOR MY INTERNATIONAL RELATIONS WORK?

A: YOU SHOULD ACKNOWLEDGE INDIVIDUALS WHO PROVIDED SIGNIFICANT INTELLECTUAL INPUT OR CRITIQUE, RESEARCH ASSISTANTS, MENTORS, EDITORS, PUBLISHERS, AND FUNDING AGENCIES. BE SPECIFIC AND GENUINE IN YOUR ACKNOWLEDGEMENTS, FOCUSING ON THOSE WHO MADE A TANGIBLE DIFFERENCE TO THE WORK.

Q: HOW DOES THE PREFACE RELATE TO THE FORMAL CITATION REQUIREMENTS OF THE CHICAGO MANUAL OF STYLE?

A: WHILE THE PREFACE ITSELF DOES NOT TYPICALLY CONTAIN EXTENSIVE FOOTNOTES OR ENDNOTES, IT SETS THE STAGE FOR THE DETAILED CITATIONS THAT WILL FOLLOW IN THE MAIN TEXT. IT ESTABLISHES THE INTELLECTUAL CONTEXT, AND THE READER WILL LATER FIND THE DOCUMENTED EVIDENCE FOR THE CLAIMS AND INFLUENCES MENTIONED WITHIN THE PREFACE.
