OFFERING FINAL THOUGHTS OR SUGGESTIONS FOR FUTURE RESEARCH

A FORWARD-LOOKING PERSPECTIVE CAN GREATLY ENHANCE YOUR CONCLUSION. YOU MIGHT SUGGEST AREAS FOR FURTHER INVESTIGATION THAT YOUR RESEARCH HAS OPENED UP, OR PROPOSE NEW QUESTIONS THAT ARISE FROM YOUR FINDINGS. IT CAN ALSO SERVE AS A POWERFUL CALL TO ACTION FOR OTHER SCHOLARS.

STRATEGIES FOR WRITING A POWERFUL CONCLUSION

CRAFTING A CONCLUSION THAT RESONATES REQUIRES MORE THAN JUST CHECKING OFF THE ESSENTIAL COMPONENTS. STRATEGIC WRITING TECHNIQUES CAN ELEVATE YOUR CONCLUSION FROM ADEQUATE TO EXCEPTIONAL, LEAVING A MEMORABLE IMPACT ON YOUR AUDIENCE.

EVEN EXPERIENCED WRITERS CAN FALL INTO COMMON TRAPS WHEN WRITING THEIR CONCLUSIONS. BEING AWARE OF THESE POTENTIAL ISSUES CAN HELP YOU STEER CLEAR OF THEM AND ENSURE YOUR FINAL STATEMENT IS AS STRONG AS POSSIBLE.

MERELY SUMMARIZING WITHOUT SYNTHESIS

ONE OF THE MOST FREQUENT ERRORS IS TO SIMPLY LIST THE MAIN POINTS OF EACH SECTION WITHOUT OFFERING ANY DEEPER ANALYSIS OR SYNTHESIS. A TRUE CONCLUSION CONNECTS THESE POINTS, HIGHLIGHTING THEIR COLLECTIVE MEANING AND CONTRIBUTION TO YOUR OVERALL ARGUMENT. IT'S ABOUT SHOWING HOW THE PARTS FORM A MEANINGFUL WHOLE.

INTRODUCING NEW MATERIAL

AS MENTIONED EARLIER, INTRODUCING NEW INFORMATION IS A SIGNIFICANT MISSTEP. IT CAN CONFUSE THE READER AND UNDERMINE THE CREDIBILITY OF YOUR RESEARCH. THE CONCLUSION IS ABOUT WRAPPING UP WHAT HAS BEEN PRESENTED, NOT OPENING NEW AVENUES THAT HAVEN'T BEEN EXPLORED OR SUPPORTED.

APOLOGIZING OR BEING TOO TENTATIVE

PHRASES LIKE "I MAY NOT HAVE COVERED EVERYTHING" OR "THIS IS JUST ONE PERSPECTIVE" CAN WEAKEN YOUR CONCLUSION. WHILE ACKNOWLEDGING LIMITATIONS IS SOMETIMES APPROPRIATE IN ACADEMIC WORK, THE CONCLUSION SHOULD ULTIMATELY PRESENT YOUR FINDINGS WITH CONFIDENCE AND CONVICTION. PRESENT YOUR RESEARCH AS A SOLID CONTRIBUTION.

ENDING ABRUPTLY OR TOO SOON

A CONCLUSION THAT IS TOO SHORT OR ENDS ABRUPTLY CAN LEAVE THE READER FEELING UNSATISFIED. IT NEEDS ENOUGH SPACE TO ADEQUATELY SYNTHESIZE YOUR ARGUMENTS AND DISCUSS THEIR IMPLICATIONS. ENSURE IT FEELS LIKE A NATURAL AND COMPLETE CLOSING, NOT A SUDDEN HALT.

REVISITING AND REFINING YOUR CONCLUSION

THE PROCESS OF WRITING A STRONG CONCLUSION DOESN'T END WITH THE FIRST DRAFT. LIKE ALL PARTS OF A RESEARCH PAPER, THE CONCLUSION BENEFITS IMMENSELY FROM CAREFUL REVISION AND REFINEMENT TO ENSURE ITS CLARITY, IMPACT, AND ADHERENCE TO CHICAGO STYLE GUIDELINES.

CHECKING FOR CLARITY AND COHERENCE

READ YOUR CONCLUSION ALOUD TO CATCH ANY AWKWARD PHRASING OR LOGICAL GAPS. ENSURE THAT THE CONNECTION BETWEEN YOUR RESTATED THESIS, SUMMARIZED FINDINGS, AND BROADER IMPLICATIONS IS CLEAR AND EASY FOR THE READER TO FOLLOW. EVERY SENTENCE SHOULD CONTRIBUTE TO THE OVERALL MESSAGE YOU WANT TO LEAVE.

ENSURING IT ALIGNS WITH THE REST OF THE PAPER

VERIFY THAT YOUR CONCLUSION ACCURATELY REFLECTS THE ARGUMENTS AND EVIDENCE PRESENTED IN THE BODY OF YOUR PAPER. IT SHOULD NOT INTRODUCE IDEAS THAT CONTRADICT OR ARE NOT SUPPORTED BY THE MAIN TEXT. CONSISTENCY IS KEY TO ACADEMIC INTEGRITY.

PROOFREADING FOR ERRORS

EVEN MINOR GRAMMATICAL ERRORS OR TYPOS CAN DETRACT FROM THE PROFESSIONALISM OF YOUR CONCLUSION. THOROUGHLY PROOFREAD YOUR WORK, PAYING CLOSE ATTENTION TO PUNCTUATION, SPELLING, AND SENTENCE STRUCTURE. GETTING FEEDBACK FROM PEERS OR INSTRUCTORS

SOMETIMES, AN OUTSIDE PERSPECTIVE IS INVALUABLE. SHARING YOUR CONCLUSION WITH A TRUSTED PEER, WRITING CENTER TUTOR, OR YOUR INSTRUCTOR CAN PROVIDE INSIGHTS INTO AREAS THAT MIGHT BE UNCLEAR OR COULD BE STRENGTHENED. THEY CAN OFFER SUGGESTIONS ON HOW TO IMPROVE ITS IMPACT AND EFFECTIVENESS.

CONSIDERING THE CHICAGO MANUAL OF STYLE GUIDELINES

WHILE THE CHICAGO MANUAL OF STYLE PRIMARILY FOCUSES ON CITATION AND FORMATTING, ITS PRINCIPLES OF CLARITY, PRECISION, AND ACADEMIC RIGOR APPLY TO ALL ASPECTS OF A RESEARCH PAPER, INCLUDING THE CONCLUSION. A: TO EFFECTIVELY RESTATE YOUR THESIS, REPHRASE IT IN A WAY THAT REFLECTS THE INSIGHTS GAINED THROUGH YOUR RESEARCH. IT SHOULD ACKNOWLEDGE HOW YOUR ARGUMENTS AND EVIDENCE HAVE PROVEN OR ELABORATED UPON YOUR INITIAL STATEMENT, DEMONSTRATING INTELLECTUAL PROGRESSION.

Q: WHAT IS THE DIFFERENCE BETWEEN A SUMMARY AND A SYNTHESIS IN A CONCLUSION?

A: A SUMMARY MERELY LISTS OR RECAPS THE MAIN POINTS. A SYNTHESIS, ON THE OTHER HAND, CONNECTS THESE POINTS, SHOWS HOW THEY WORK TOGETHER TO SUPPORT YOUR THESIS, AND HIGHLIGHTS THEIR COLLECTIVE MEANING AND CONTRIBUTION.

Q: SHOULD I ACKNOWLEDGE LIMITATIONS OF MY RESEARCH IN THE CONCLUSION?

A: YES, IT CAN BE APPROPRIATE AND OFTEN STRENGTHENS YOUR CONCLUSION TO BRIEFLY ACKNOWLEDGE ANY LIMITATIONS OF YOUR RESEARCH. THIS DEMONSTRATES CRITICAL SELF-AWARENESS AND CAN ALSO LEAD TO SUGGESTIONS FOR FUTURE RESEARCH.

Q: HOW CAN I MAKE MY CONCLUSION MORE IMPACTFUL?

A: YOU CAN MAKE YOUR CONCLUSION MORE IMPACTFUL BY CONNECTING IT BACK TO YOUR INTRODUCTION, DISCUSSING BROADER IMPLICATIONS, OFFERING A FORWARD-LOOKING PERSPECTIVE, AND USING STRONG, CONFIDENT LANGUAGE.
