Understanding Chicago Style for Social Sciences

Author-Date System: The Core of Chicago Social

Science Citations

The author-date system, as used in the Chicago Manual of Style, relies on parenthetical in-text citations that include the author's last name and the year of publication. This method is distinct from the notes-bibliography system, which uses footnotes or endnotes. For social science research, the author-date approach streamlines the citation process and enhances readability by minimizing interruptions in the narrative flow. The accompanying bibliography then provides the full details of each source cited.

The fundamental principle is to provide enough information in the in-text citation to direct the reader to the full entry in the bibliography. This typically includes the author's surname and the publication year. When citing specific passages, page numbers are also included. This concise yet informative approach ensures that the author's work is properly acknowledged without disrupting the reader's engagement with the content. The consistent application of this system is key to maintaining academic rigor.

Citing Books in Chicago Style

Citing books is a fundamental skill for any social science researcher. In the author-date system, the bibliography entry for a book typically includes the author's last name, first name, publication year, title of the book (italicized), and publication information. The in-text citation will then consist of the author's last name and the year of publication.

Single-Author Book

For a book written by a single author, the bibliography entry follows a standard format. The author's name appears with the last name first, followed by their first name. The publication year is enclosed in parentheses. The title of the book is italicized, and the location of the publisher followed by the publisher's name completes the entry.

- Author, A. A. (Year). *Title of book*. City, State: Publisher.

For example:

- Smith, John. (2021). *The Dynamics of Urban Inequality*. Chicago, IL: University of Chicago Press.

Book with Multiple Authors

When citing a book with two or three authors, list all authors' names in the bibliography entry. For books with four or more authors, list the first author followed by "et al." in the bibliography, but list all authors in the note if using the notes-bibliography system. For the author-date system's

bibliography, Chicago prefers listing all authors up to ten; for more than ten, the first author is followed by "et al."

- Author, A. A., Author, B. B., & Author, C. C. (Year). *Title of book*. City, State: Publisher.
- Author, A. A., et al. (Year). *Title of book*. City, State: Publisher. (For 4+ authors, with the first author listed)

For example:

- Davis, R. L., Miller, S. K., & Chen, P. (2020). *Global Social Movements and Their Trajectories*. New York, NY: Oxford University Press.

Edited Book

Edited books require specifying the editor(s) rather than an author. The bibliography entry will list the editor's name(s) followed by "ed." or "eds." after their name(s). The title of the book remains italicized.

- Editor, E. E. (Ed.). (Year). *Title of book*. City, State: Publisher.
- Editor, E. E., & Editor, F. F. (Eds.). (Year). *Title of book*. City, State: Publisher.

For example:

- Garcia, M. A. (Ed.). (2019). *Perspectives on Political Polarization*. London, UK: Routledge.

Chapter in an Edited Book

When referencing a specific chapter within an edited book, the citation needs to include the chapter author, chapter title, book editor(s), book title, and publication details. This provides a precise reference to the specific contribution within the larger work.

- Chapter Author, C. C. (Year). Title of chapter. In E. E. Editor & F. F. Editor (Eds.), *Title of book* (pp. page numbers). City, State: Publisher.

For example:

- Johnson, L. M. (2022). The impact of technology on democratic processes. In M. A. Garcia (Ed.), *Perspectives on Political Polarization* (pp. 112-135). London, UK: Routledge.

Citing Journal Articles in Chicago Style

Journal articles are a cornerstone of social science research, and their proper citation is vital. The author-date system in Chicago style requires specific formatting for these entries to ensure clarity and ease of retrieval.

Journal Article with Page Numbers

The standard format for a journal article in the author-date system includes the author(s), year of publication, article title, journal title (italicized), volume number, issue number, and page numbers. The journal title is often followed by a comma and then the volume and issue information.

- Author, A. A. (Year). Title of article. *Title of Journal*, Volume(Issue), page numbers.

Journal Article with a DOI

If a journal article has a Digital Object Identifier (DOI), it should be included in the citation. DOIs provide a persistent link to the article, making it easier for readers to find. The DOI is typically placed at the end of the citation, often as a URL.

- Author, A. A. (Year). Title of article. *Title of Journal*, Volume(Issue), page numbers. DOI: XXXX

For example:

- Brown, P. D. (2022). The influence of media narratives on public opinion. *Political Science Quarterly*, 137(1), 55-78. DOI: 10.1002/psq.12345

Citing Websites and Online Resources in Chicago Style

The internet has become an indispensable source of information for social scientists. Citing websites and online resources requires careful attention to detail, including the author (if identifiable), publication date, title, and the URL. When an author or publication date is not readily apparent, the citation should reflect this absence.

Web Page with Author and Date

For a webpage with a clearly identified author and publication date, the citation format is similar to other sources, with the inclusion of the URL and the date accessed.

- Author, A. A. (Year, Month Day). *Title of webpage*. Retrieved from URL

For example:

- Lee, S. Y. (2023, March 15). *The evolving landscape of remote work*. Retrieved from <https://www.example.com/remotework>

Web Page without Author or Date

When author and/or date information is unavailable, the citation should proceed with the available information, often starting with the title of the webpage. The date accessed is always crucial for online sources, as content can change or disappear.

- *Title of webpage*. (n.d.). Retrieved Month Day, Year, from URL

For example:

- *Global poverty statistics and trends*. (n.d.). Retrieved October 26, 2023, from <https://www.worldbank.org/povertystats>

Citing Other Common Social Science Sources

Social science research often draws from a variety of sources beyond books and journal articles. Proper citation for these materials is equally important for maintaining academic integrity.

Government Documents

Government reports and publications are frequently used in social science research. The citation format typically includes the issuing agency, the title of the document, and publication details.

- Issuing Agency. (Year). *Title of document*. Report Number (if applicable). City, State: Publisher.

For example:

- U.S. Department of Commerce, Bureau of the Census. (2022). *Statistical Abstract of the United States*. Washington, D.C.: Government Printing Office.

Dissertations and Theses

Academic dissertations and theses represent significant original research. When citing them, it's important to identify the author, year, title, and the institution from which it was awarded, along with the type of document (e.g., PhD dissertation, Master's thesis).

- Author, A. A. (Year). *Title of dissertation* (PhD dissertation or Master's thesis). Institution Name, Location.

For example:

- Chen, L. (2021). *The psychological impact of social media on adolescent self-esteem* (PhD dissertation). Stanford University, Stanford, CA.

Conference Proceedings

Presentations and papers delivered at academic conferences are valuable sources. Citations should include the author, year, title of the paper, name of the conference, and location or publication details of the proceedings.

- Author, A. A. (Year, Month). *Title of paper*. Paper presented at the [Name of Conference], City, State.

For example:

- Rodriguez, J. M. (2020, June). *Analyzing voting patterns in local elections*. Paper presented at the Annual Conference of Political Scientists, Boston, MA.

In-Text Citations in Chicago Style

In the author-date system, in-text citations are brief and appear within the body of your text. They serve to acknowledge the source of information immediately and direct the reader to the full citation in the bibliography. The general format is the author's last name followed by the year of publication. If you are quoting directly or referring to a specific passage, you must also include the page number(s).

When the author's name is mentioned in the text as part of your sentence, you only need to include the year in parentheses immediately following their name. This integration makes the citation feel more natural within the flow of your writing. For instance, "As Foucault (1979) argued, power operates in subtle and pervasive ways."

If the author's name is not mentioned in the sentence, both the author's last name and the year of publication are enclosed in parentheses. For example, "The concept of social capital has been widely debated in recent years (Bourdieu 1986)." When referring to a specific point or quote, include the page number(s) after the year, separated by a comma. For example: (Bourdieu 1986, 24).

For sources with no identifiable author, use a shortened version of the title in place of the author's name, enclosed in quotation marks if it's an article or chapter title, or italicized if it's a standalone work like a book or report. For example: ("The Future of Work" 2023) or (*Global Trends Report* 2022).

Bibliography Formatting in Chicago Style

The bibliography, which appears at the end of your paper, provides a complete alphabetical list of all sources cited in your work. It is crucial for allowing your readers to locate and consult your sources. Each entry must be meticulously formatted according to the Chicago Manual of Style guidelines for the author-date system.

Entries are arranged alphabetically by the author's last name. If a source has no author, it is alphabetized by the first significant word of its title. The first line of each entry is flush with the left margin, and subsequent lines are indented. This hanging indent format makes it easier to scan the list for specific authors or titles.

Consistency is key. Ensure that all elements of each citation—author's name, year, title, publication details—are present and correctly formatted for every source listed.
