Understanding the Chicago Manual of Style

In the bibliography: Doe, Jane. "Qualitative Methods in Modern Sociology." *Journal of Sociological Research* 25, no. 3 (2019): 210-235. For the author-date system, the in-text citation would be (Doe 2019, 215), and the bibliography entry: Doe, Jane. 2019. "Qualitative Methods in Modern Sociology." *Journal of Sociological Research* 25, no. 3: 210-235.

Citing Online Sources

The digital landscape presents unique challenges for citation. Chicago style offers guidance on citing websites, online articles, and other digital content. For online articles with a DOI (Digital Object Identifier), the DOI is preferred over a URL. A typical citation for an online source in a note might include the author, title, website name, publication date, and URL or DOI. For example: Robert Johnson, "The Future of Political Polarization," *The Policy Review*, October 15, 2022, <https://www.policyreview.com/future-polarization>. For the author-date system, the in-text citation would be (Johnson 2022).
