Manuscript Preparation: The Foundation of Your Submission

For example, a citation might appear as (Smith 2020).

Citing Specific Information

When you quote directly from a source, you must also include the page number. This is formatted as (Author Year, Page Number). For instance, (Smith 2020, 45). If you are paraphrasing or summarizing an idea, the page number is often optional but recommended for clarity and ease of verification, especially if the source is lengthy or complex. For multiple authors, follow the specific rules outlined in the Chicago Manual of Style regarding how to list names and conjunctions.

Handling Multiple Sources and Works by the Same Author

When citing multiple works in a single parenthetical reference, list them in alphabetical order by author's last name, separated by semicolons. For example, (Adams 2018; Brown 2019; Clark 2021). If you are referencing two or more works by the same author published in the same year, you will need to append lowercase letters to the year (e.g., 2020a, 2020b) in both your in-text citations and your bibliography. This distinction is crucial for ensuring accurate referencing.

The Notes and Bibliography System: Footnotes and Endnotes

While the Author-Date system is common in social sciences, the Notes and Bibliography system, which utilizes footnotes or endnotes, is also widely accepted and often preferred in certain fields, particularly history and the arts. This system involves placing a superscript numeral at the end of a sentence or clause to indicate a citation. These numbers correspond to notes at the bottom of the page (footnotes) or at the end of the document (endnotes).

Footnotes and Endnotes Format

The first time a source is cited in a note, the citation provides a full bibliographic entry. Subsequent citations for the same source can be

shortened. A typical full note citation includes the author's first and last name, the title of the work (italicized), publication information, and the page number. For example: Jane Doe, *Theories of Social Change* (Chicago: University of Chicago Press, 2022), 78. A shortened subsequent note might look like: Doe, *Theories of Social Change*, 92.

When to Use Notes

Notes are not solely for citations; they can also be used for supplementary material, explanations, or digressions that might interrupt the flow of the main text but are important for the reader to know. This flexibility makes the Notes and Bibliography system valuable for providing deeper context or elaborating on specific points without disrupting the primary narrative. Social scientists sometimes use notes to acknowledge research assistance or other acknowledgments.

Crafting Your Bibliography or Reference List

Regardless of whether you use the Author-Date system or the Notes and Bibliography system, a comprehensive bibliography or reference list at the end of your manuscript is a non-negotiable component of Chicago style social science submission guidelines. This list provides full details for all the sources you have cited, allowing readers to locate and consult them. The format of this list differs slightly depending on the citation system used.

Bibliography Format (for Notes and Bibliography System)

A bibliography is typically arranged alphabetically by the author's last name. Publication City: Publisher, Year. For edited volumes, it would be Editor's Last Name, First Name, ed. *Title of Edited Work*. Publication City: Publisher, Year. Reference List Format (for Author-Date System)

A reference list under the Author-Date system is also alphabetized by author's last name. The format for each entry is generally: Author's Last Name, First Name. Year. *Title of Work*. Publication City: Publisher. For journal articles, it would be Author's Last Name, First Name. Year. "Title of Article." *Title of Journal* Volume (Issue): Page Numbers. The year is placed immediately after the author's name to align with the in-text citations. Pay

close attention to the specific formatting for different types of sources, such as books, journal articles, websites, and dissertations.

Common Elements in Both Lists

Key elements that appear in both bibliographies and reference lists include the author(s), title, publisher, publication date, and for articles or chapters, the title of the larger work and its page range. Ensure accuracy in all details, from spelling of names to publication years. The goal is to provide sufficient information for anyone to find the source with minimal effort.

Specific Considerations for Social Science Disciplines

While the core principles of Chicago style remain constant, certain nuances are particularly relevant to social science disciplines.
