Websites and Online Articles

For online sources, include the author (if available), title of the specific page or article, name of the website, publication date (or last updated date), and the URL. It's also good practice to include an access date.

Newspaper and Magazine Articles

Similar to journal articles, these citations include author, article title, publication name, date, and page numbers (if applicable). For online newspaper articles, include the URL and access date.

- **Subsequent Footnote/Endnote Citation:** 8. Brooks, "American Family 2.0."

Interviews

Personal interviews are cited by identifying the interviewee, the type of interview (e.g., personal interview, phone interview), the date, and location if relevant. These are typically not included in the bibliography unless they have been formally published.

- **Footnote/Endnote Citation:** 9. Jane Doe, personal interview by author, October 10, 2023, Chicago, IL.

Chicago Style: Author-Date System Explained

The Author-Date system offers a more concise approach to citation, relying on brief in-text parenthetical citations that direct the reader to a full list of references at the end of the paper. This method is often preferred in fields where direct referencing to the source is paramount for immediate verification. The in-text citation typically includes the author's last name and the year of publication, followed by a page number if a specific passage is being quoted or paraphrased.

The end matter for the Author-Date system is a "References" list (not a "Bibliography"). This list contains full bibliographic details for all sources cited in the text, arranged alphabetically by author's last name. The primary advantage of this system is its streamlined presentation within the main body of the paper, allowing for a smoother reading experience while still providing complete source information.

Interviews

Personal interviews are typically not included in the reference list for the Author-Date system unless they have been formally published or archived. In-Text Citations in Chicago Style

Regardless of whether you are using the Notes-Bibliography or Author-Date system, in-text citations serve the crucial purpose of alerting your reader to the source of information. In the Notes-Bibliography system, these are typically superscript numbers placed after the relevant quotation, paraphrase, or idea. In the Author-Date system, it's a parenthetical citation

usually containing the author's last name and the publication year, with a page number often included for direct quotes or specific paraphrases.
