Understanding the Two Chicago Style Systems

The Chicago Manual of Style offers two distinct citation systems: the author-date system and the notes-bibliography system. In-Text Citations in Sociology

The Author-Date System for Sociological Research

In the author-date system, citations appear directly within the text, typically in parentheses. This method is favored for its directness and ease

of integration into the flow of writing. A typical author-date citation includes the author's last name, the year of publication, and, if quoting directly, the page number. For instance, a citation for a book by Durkheim published in 1897 on suicide would appear as (Durkheim 1897, 150) if a direct quote is used. If paraphrasing, the page number may be omitted unless clarity demands it.

When multiple authors are involved, the convention changes. For two authors, both last names are included, separated by "and" within the text and by an ampersand (&) within parentheses: (Smith and Johnson 2010) or Smith and Johnson (2010). For three or more authors, only the first author's last name is listed, followed by "et al." (meaning "and others"): (Williams et al. 2015). This ensures conciseness when dealing with extensive collaborative works common in sociological studies.

The Notes-Bibliography System for Sociological Works

The notes-bibliography system utilizes superscript numbers embedded in the text to refer to footnotes or endnotes. These notes contain the source information. For a first mention of a source, the note includes full bibliographic details. Subsequent mentions of the same source use a shortened form, typically including the author's last name, a shortened title, and the page number. For example, a first citation might be: 1. The choice between footnotes and endnotes is largely stylistic. Footnotes appear at the bottom of the page where the citation is made, while endnotes are gathered at the end of the paper. Both systems require a comprehensive bibliography at the end of the paper, listing all sources cited. This detailed approach allows for richer annotation and can be beneficial for complex arguments in sociological theory or historical analysis.

Creating Bibliographical Entries

Book Entries in Chicago Style for Sociology

When citing a book in the author-date system, the bibliography entry follows the format: Last Name, First Name. Year. Title of Book. Place of Publication: Publisher. For example: Bourdieu, Pierre. 1984. *Distinction: A Social Critique of the Judgement of Taste*. Cambridge, MA: Harvard University Press. The title is italicized. In the notes-bibliography system, the entry is slightly different, often beginning with the author's first name: Bourdieu, Pierre. *Distinction: A Social Critique of the Judgement of Taste*. For edited books, the primary author listed is the editor. For example, if a collection of essays on urban sociology is edited by Jane Adams, the entry would be Adams, Jane, ed. *Urban Sociology Reader*. New York: Routledge, 2018. The designation "ed." for editor is crucial. For books with multiple

editions, the edition number is included after the title, such as *Sociological Theory*, 2nd ed. (New York: W. W. Norton, 2010).

Journal Article Entries for Sociological Publications

Citing journal articles is a frequent necessity in sociological research. In the author-date system, the bibliography format is: Last Name, First Name. Year. "Title of Article." Title of Journal Volume (Issue): Page range. For instance: Granovetter, Mark. 1973. "The Strength of Weak Ties." *American Journal of Sociology* 78 (6): 1360-1380. Note the quotation marks around the article title and italics for the journal title.

For the notes-bibliography system, the journal article citation typically begins with the author's first name: Granovetter, Mark. "The Strength of Weak Ties." *American Journal of Sociology* 78, no. 6 (May 1973): 1360-1380. The inclusion of the issue number and sometimes the month or season of publication is standard. When citing online journal articles, you should include a DOI (Digital Object Identifier) if available, or a URL and access date. For example: Lee, Joon. 2020. "Digital Inequality in the Pandemic Era." *Sociological Inquiry* 90 (3): 450-475. <https://doi.org/10.1111/soin.12345>.

Citing Other Sociological Sources

Sociological research often involves a variety of sources beyond books and journal articles. When citing a chapter in an edited book, the author-date format is: Last Name, First Name. Year. "Title of Chapter." In Title of Book, edited by Editor's First Name Last Name, Page range. Place of Publication: Publisher. For example: Scott, Joan Wallach. 1999. "Gender: A Useful Category of Historical Analysis." In *Feminism and History*, edited by Joan Scott and Judith Butler, 15-41. New York: Oxford University Press.

When citing websites or online reports, clarity and completeness are paramount. For the author-date system, a typical entry might be: Organization Name. Year. Title of Report or Webpage. Accessed Month Day, Year. URL. Example: Pew Research Center. 2021. Key Findings About the American Middle Class. Accessed October 26, 2023. <https://www.pewresearch.org/social-trends/2021/04/22/key-findings-about-the-american-middle-class/>. Always ensure that the URL is stable and that sufficient information is provided for retrieval.

Formatting Your Sociology Paper in Chicago Style

General Formatting Guidelines
