WHEN PREPARING A CHICAGO STYLE SUMMARY FOR THESES, IT IS IMPERATIVE TO INCLUDE SPECIFIC PIECES OF INFORMATION THAT ACCURATELY REFLECT THE RESEARCH. THESE INCLUDE:

CRAFTING AN EFFECTIVE INTRODUCTION FOR YOUR SUMMARY

CONCLUDING YOUR CHICAGO STYLE SUMMARY FOR THESES, THE DISCUSSION OF IMPLICATIONS AND FUTURE RESEARCH PROVIDES CONTEXT AND FORWARD-LOOKING PERSPECTIVE. FURTHERMORE, IT IS COMMON IN THESIS SUMMARIES TO SUGGEST AVENUES FOR FUTURE RESEARCH. THIS DEMONSTRATES A DEEP ENGAGEMENT WITH YOUR TOPIC AND ACKNOWLEDGES THAT RESEARCH IS AN ONGOING PROCESS.
