DISTINCTION BETWEEN SUMMARY AND ABSTRACT

WHILE OFTEN USED INTERCHANGEABLY, IT'S IMPORTANT TO NOTE THAT IN SOME ACADEMIC TRADITIONS, A DISTINCTION EXISTS BETWEEN A SUMMARY AND AN ABSTRACT. HOWEVER, FOR THE PURPOSE OF THIS GUIDE, WE WILL CONSIDER THE "CHICAGO STYLE SUMMARY FOR THESIS" TO ENCOMPASS THE FUNCTION TYPICALLY PERFORMED BY AN ABSTRACT. AN ABSTRACT IS GENERALLY MORE FOCUSED ON RESEARCH SPECIFICS, INCLUDING METHODOLOGY AND KEY FINDINGS, WHEREAS A BROADER "SUMMARY" MIGHT ALLOW FOR SLIGHTLY MORE CONTEXT OR INTRODUCTORY MATERIAL. IN THE CHICAGO MANUAL OF STYLE (CMOS) CONTEXT, A THESIS SUMMARY OR ABSTRACT SHOULD BE A STANDALONE REPRESENTATION OF THE ENTIRE WORK.

KEY COMPONENTS OF A CHICAGO STYLE SUMMARY FOR THESIS

A ROBUST CHICAGO STYLE SUMMARY FOR THESIS MUST EFFECTIVELY COMMUNICATE THE CORE ELEMENTS OF YOUR RESEARCH.

CONCLUSIONS AND IMPLICATIONS

THE SUMMARY SHOULD CONCLUDE BY OUTLINING THE MAIN CONCLUSIONS DRAWN FROM YOUR RESEARCH. WHAT DO YOUR FINDINGS MEAN IN THE BROADER CONTEXT OF YOUR FIELD? DISCUSS THE IMPLICATIONS OF YOUR WORK, ITS CONTRIBUTIONS TO KNOWLEDGE, AND POTENTIAL AVENUES FOR FUTURE RESEARCH. THIS SECTION REINFORCES THE SIGNIFICANCE OF YOUR THESIS AND ITS IMPACT.

WRITING AN EFFECTIVE CHICAGO STYLE SUMMARY FOR THESIS: BEST PRACTICES

CRAFTING A COMPELLING CHICAGO STYLE SUMMARY FOR THESIS REQUIRES CAREFUL ATTENTION TO DETAIL, CLARITY, AND CONCISENESS. IT SHOULD BE DOUBLE-SPACED IF THE REST OF YOUR THESIS IS, OR SINGLE-SPACED IF THAT IS THE CONVENTION. CONSULT YOUR SPECIFIC DEPARTMENTAL OR UNIVERSITY GUIDELINES FOR PRECISE FORMATTING REQUIREMENTS.

EXAMPLES AND APPLICATIONS

IT WOULD THEN OUTLINE THE METHODOLOGY: A MIXED-METHODS STUDY INVOLVING SURVEYS OF RESIDENTS IN AREAS WITH VARYING GREEN SPACE AVAILABILITY AND QUALITATIVE INTERVIEWS. KEY FINDINGS WOULD HIGHLIGHT A SIGNIFICANT POSITIVE CORRELATION BETWEEN ACCESS TO GREEN SPACES AND REPORTED LEVELS OF STRESS REDUCTION AND INCREASED SOCIAL INTERACTION. THE CONCLUSION WOULD EMPHASIZE THE IMPORTANCE OF URBAN PLANNING THAT PRIORITIZES GREEN INFRASTRUCTURE FOR PUBLIC HEALTH BENEFITS.

COMMON PITFALLS TO AVOID
