MLA Style for Conference Papers

The Modern Language Association (MLA) style is commonly used in the humanities, particularly in English and literature studies. MLA emphasizes the author and title, and its guidelines for citing conference papers have evolved to accommodate digital and unpublished works.

For a paper presented at a conference and published in its proceedings, the format typically looks like this:

Chicago Style for Conference Papers

The Chicago Manual of Style offers two main systems: the notes-bibliography system (common in humanities) and the author-date system (common in social sciences). Both systems can be used to cite conference papers.

The bibliography entry would be similar but formatted differently. For a published paper:

- Author Last Name, First Name. "Title of Paper." In Title of Conference Proceedings, edited by Editor First Name Last Name, page numbers. Publisher, Year.

For an unpublished paper presented at a conference:

- Author Last Name, First Name. "Title of Paper." Presented at the Conference Name, Location, Month Day, Year.

The author-date system would follow a similar pattern but with author and date appearing first in the reference list.

IEEE Style for Conference Papers

The Institute of Electrical and Electronics Engineers (IEEE) citation style is widely used in engineering, computer science, and related fields. IEEE emphasizes conciseness and a standardized format.

For a published conference paper, the typical format is:

- [1] Author(s) initials. Last name, "Title of paper," presented at the Abbreviated Name of Conference, Location, Date. DOI (if available).

If published in proceedings, it would look like:

- [1] Author(s) initials. Last name, "Title of paper," Abbreviated Name of Conference Proceedings, vol. X, no. Y, pp. xxx-xxx, Date. DOI (if available).
