Chicago (Chicago Manual of Style) Style

The Chicago Manual of Style is a comprehensive style guide that offers two distinct systems of citation: the notes-bibliography system and the author-date system. The notes-bibliography system is commonly used in history, literature, and the arts, while the author-date system is more prevalent in the social sciences.

In the notes-bibliography system, superscript numbers in the text refer to footnotes or

endnotes, which contain full citation information. The bibliography at the end of the paper provides a list of all sources consulted. In the author-date system, in-text citations resemble APA style, with the author and year, and a reference list follows. Chicago's flexibility makes it adaptable to various academic disciplines.
