The Author's Name

The citation typically begins with the author's name. For websites, this might be an individual author, a corporate author (like an organization or institution), or in some cases, no author is listed. If an individual author is credited, format their name as Last Name, First Name. If no individual author is provided, look for a corporate author, which will be listed by its organizational name. In the absence of both, you may begin the citation with the title of the work itself.

The Title of the Source

This refers to the specific article, page, or document you are citing. It should be enclosed in quotation marks. For instance, if you are citing an article titled "The Future of Renewable Energy" from a website, this would be the "Title of the Source." Be precise and use the exact title as it appears on the webpage. Consistency in how you format these titles is key to maintaining a professional and organized Works Cited page.

The Title of the Container

A "container" in MLA refers to a larger work that houses the source. For websites, the primary container is usually the website itself, followed by its publisher if they differ from the website's name. For example, if you are citing an article from a news website, the website's name would be considered the container. If you are citing a page within a larger online database or archive, that database would be the container.

Including the Publisher

Publication Date and Location (URL)

While MLA historically recommended removing "http://" or "https://," it's now acceptable to include them if the URL is essential for finding the source, especially for pages that might be behind a login or are frequently updated.

Locating the Title of the Source and Website

(no date) in your citation, although this is less ideal as it doesn't indicate the currency of the information.

Citing Blog Posts and Social Media

Blog posts are treated similarly to articles on a website, with the blog's name acting as the container. You should include the date of the post and, where applicable, a URL or a description of the post (e.g., the first 20 words of a tweet).

- Author's Username. "Content of the Post." *Platform Name*, Day Month Year, URL.

For example:

- @AcademicWriter. "Tips for citing websites in MLA style are essential for clear academic writing. MLA9 Citation." *Twitter*, 16 Nov. 2023, twitter.com/AcademicWriter/status/1234567890.

Online Videos and Multimedia

When citing online videos (e.g., from YouTube, Vimeo), treat the video title as the source title and the platform as the container. Include the uploader's name if it's distinct from the channel name, the title of the video, the platform name, the publication date, and the URL. For longer videos, you might also note the specific time stamps if you are referencing a particular

segment.

- Uploader's Name. "Title of Video." *Name of Website*, Publisher (if applicable), Day Month Year of Upload, URL.

Electronic Journal Articles and E-books

Scholarly articles found online through databases (like JSTOR or Academic Search Premier) or on the journal's website are cited similarly to print journal articles, but with the addition of the database name (as the container) and a DOI (Digital Object Identifier) or URL. E-books are cited with information similar to print books, but with the addition of an electronic access location, such as a URL or database name.

In-Text Citations for Websites in MLA Style

In-text citations are brief references within the body of your paper that direct readers to the full citation on your Works Cited page. For website sources, MLA employs a straightforward parenthetical citation system. The primary goal is to provide enough information to identify the source without disrupting the flow of your prose. The Basic Parenthetical Citation

The most common form of MLA in-text citation includes the author's last name and the page number, if available. However, many websites do not have page numbers. Handling Websites Without Page Numbers

As most web pages lack pagination, the MLA style guide has adapted to this reality. When citing a source from a website that does not have page numbers, you will typically only include the author's last name in your parenthetical

citation. If the author is unknown, you will use the shortened title of the work, enclosed in quotation marks, as the locator in your citation.

Indirect Sources on Websites

Sometimes, you might find a quotation or information on a website that is attributed to another source. This is called an indirect source. In such cases, you should cite the original source in your in-text citation and include the abbreviation "qtd. in" (quoted in) followed by the author of the work you are referencing (the website author in this scenario).

Example:

According to Dr. Evelyn Reed, "climate change is accelerating" (qtd. in Smith).

In these cases, if you cannot find a stable URL, you may need to describe how you accessed the information, or in some instances, it might be advisable to print out the page or save it as a PDF to retain a stable reference point. However, MLA generally prefers URLs when available and stable.
