Understanding the Chicago Manual of Style for Political

Example of a reference list entry:

Smith, John. 2021. *Theories of International Relations*. New York: Oxford University Press.

Edited Books and Chapters

Citing a chapter within an edited book requires including the chapter author, chapter title, the editor(s) of the book, the book title, and publication details. The process is similar for both citation systems, with adjustments for note formatting versus reference list or bibliography formatting.

Journal Articles in Author-Date System

The in-text citation includes the author's last name, year, and page number. The reference list entry follows a similar structure to the bibliography entry but places the year immediately after the author's name.

Example of an in-text citation:

(Doe 2022, 234)

Example of a reference list entry:

Doe, Jane. 2022. "The Evolution of Democratic Norms." *Political Science Review* 15, no. 2: 234-50.

Citing Online Sources and Websites in Political Science Chicago Style

The proliferation of online resources necessitates careful citation of websites, reports, and articles found online. Political science research often draws from think tank reports, government websites, and online journals.

Online Sources in Notes-Bibliography System

When citing online material, include as much information as available, such as author, title, website name, publication date, and a stable URL. If no publication date is available, use "n.d." for no date. Crucially, include the date you accessed the material, as online content can change.

Online Sources in Author-Date System

In-text citations are similar to other sources, with author and year. The reference list entry will include author, title, website name, and URL, with the date of access if necessary.

Pew Research Center. 2023. "Global Polling Data." Last modified October 26, 2023. Accessed November 15, 2023. <https://www.pewresearch.org/global-polling>.

Citing Government Documents and Reports
