Early Engagements and the Spark of War

The initial shots of the Civil War were fired not in a grand battlefield, but in a strategic harbor. Fought on September 17, 1862, the Battle of Antietam remains the single bloodiest day in American military history. General Robert E. Lee's first invasion of the North culminated in a brutal confrontation with General George B. McClellan's Army of the Potomac near Sharpsburg, Maryland. While tactically inconclusive, Antietam provided President Lincoln with the strategic victory he needed to issue the preliminary Emancipation Proclamation. This proclamation fundamentally changed the war's objectives, transforming it into a fight for freedom and weakening the Confederacy's ability to gain foreign recognition.

The Battle of Fredericksburg

In December 1862, the Union Army of the Potomac, now under the command of General Ambrose Burnside, launched a disastrous frontal assault against well-entrenched Confederate positions on Marye's Heights at Fredericksburg, Virginia. The Union suffered devastating casualties in what is considered one of the most one-sided Confederate victories of the war. The Battle of Chancellorsville

Considered General Robert E. Lee's "perfect battle," Chancellorsville in May 1863 saw the Confederate Army of Northern Virginia achieve a remarkable victory against a much larger Union force under General Joseph Hooker. Lee, with the brilliant tactical acumen of Stonewall Jackson, divided his forces and executed a daring flank attack, crushing the Union army. However, this triumph came at a terrible cost: Stonewall Jackson was mortally wounded by friendly fire, a loss that profoundly impacted the Confederacy's military leadership.

The Battle of Gettysburg

From July 1-3, 1863, the Battle of Gettysburg in Pennsylvania marked a critical turning point in the Eastern Theater and, arguably, the entire war. General Robert E. Lee's second invasion of the North was met by the Union Army of the Potomac, commanded by General George G. Meade. After three days of intense fighting, including the ill-fated Pickett's Charge on the final day, Lee's army was decisively defeated and forced to retreat back into Virginia. Gettysburg inflicted irreplaceable losses on the Confederate army and ended any realistic hope of a Confederate victory on Northern soil.

The Western Theater: Grant's Ascendancy

The Siege of Vicksburg

Grant's Army of the Tennessee. The fighting was savage and protracted, with both sides suffering immense casualties.
