THIS INCLUDES THE USE OF COMPUTATIONAL TOOLS FOR LARGE-SCALE TEXT ANALYSIS, NETWORK ANALYSIS TO MAP CONNECTIONS BETWEEN INDIVIDUALS OR PUBLICATIONS, AND DATA VISUALIZATION TO REPRESENT PATTERNS IN NEWSPAPER CONTENT OR CIRCULATION. DIGITIZATION PROJECTS THEMSELVES ENABLE NEW FORMS OF SEARCHABLE ACCESS AND COMPARATIVE ANALYSIS, OPENING UP PREVIOUSLY INTRACTABLE RESEARCH QUESTIONS.

- **CONTENT ANALYSIS:** SYSTEMATIC EXAMINATION AND QUANTIFICATION OF NEWSPAPER ARTICLES, ADVERTISEMENTS, AND OTHER CONTENT TO IDENTIFY TRENDS AND PATTERNS.
