THESE VOYAGES, WHILE OFTEN FRAUGHT WITH DANGER, EVENTUALLY OPENED UP NEW MARITIME PATHWAYS, FUNDAMENTALLY ALTERING GLOBAL TRADE PATTERNS AND INITIATING THE ERA OF EXTENSIVE COLONIAL TRADE.

ECONOMIC AND POLITICAL AMBITIONS

THEY POSSESSED SIGNIFICANT ECONOMIC AND EVEN MILITARY POWER, ACTING AS QUASI-GOVERNMENTAL ENTITIES IN MANY OF THEIR COLONIAL TERRITORIES, DIRECTLY SHAPING THE COURSE OF COLONIAL TRADE HISTORY.

DEMAND FOR EXOTIC GOODS AND RAW MATERIALS
