LOOK FOR FEATURES THAT CAN SPECIFICALLY FLAG SENTENCE STRUCTURES OR THE ARRANGEMENT OF IDEAS THAT ARE TOO SIMILAR TO EXISTING WORKS, WHICH IS PARTICULARLY RELEVANT FOR COMPARE AND CONTRAST STRUCTURES.

ADDITIONALLY, SOME CHECKERS HAVE LIMITED DATABASES, MEANING THEY MIGHT MISS PLAGIARISM FROM OBSCURE SOURCES OR COPYRIGHTED MATERIAL NOT YET INDEXED. LASTLY, WAITING UNTIL THE LAST MINUTE TO RUN A CHECK CAN BE A MISTAKE; UNFORESEEN ISSUES MIGHT REQUIRE SUBSTANTIAL REVISIONS, CAUSING STRESS AND POTENTIAL DELAYS. REMEMBER, A PLAGIARISM CHECKER IS A TOOL TO ASSIST YOU IN PRODUCING ORIGINAL WORK, NOT A SUBSTITUTE FOR DILIGENT RESEARCH AND PROPER CITATION HABITS.
