Westward Expansion and the Entrenchment of Slavery

The territorial gains made during the era of Manifest Destiny, such as the Louisiana Purchase and the annexation of Texas, directly led to the expansion of slavery into new regions. As the United States acquired vast tracts of land, slaveholders saw opportunities to establish new plantations and extend their economic and political power. This westward push for territory wasn't just about land; it was about securing and expanding the economic foundation of the Southern states, which was inextricably linked to the institution of slavery.
