CERTIFICATIONS SUCH AS THE CERTIFIED SHORTHAND REPORTER (CSR), REGISTERED PROFESSIONAL REPORTER (RPR), AND CERTIFIED REALTIME REPORTER (CRR) ARE HIGHLY VALUED IN BUFFALO AND CAN SIGNIFICANTLY BOOST A COURT REPORTER'S EARNING POTENTIAL BY DEMONSTRATING ADVANCED SKILLS AND COMMITMENT TO THE PROFESSION.

Q: WHAT IS THE DEMAND FOR COURT REPORTERS IN BUFFALO, AND HOW DOES IT INFLUENCE SALARIES?
