Agents must build trust, assess the reliability of sources, and ensure their safety while gathering valuable insights that are often inaccessible through other means.

Counter-narcotics intelligence: This broad category refers to intelligence activities focused specifically on combating illicit drug production, trafficking, and use. It involves a multidisciplinary approach, integrating information from various sources to understand and disrupt the global drug trade. Counter-narcotics intelligence is a vital component of national security strategies worldwide.

DEA operational support intelligence: This type of intelligence directly supports active DEA investigations and enforcement operations. Analysts provide real-time information, target packages, and background research to assist agents in the field, ensuring that operations are intelligence-driven and have a higher likelihood of success.

Intelligence cycle drug enforcement: This refers to the systematic process by which intelligence is collected, processed, analyzed, produced, and disseminated within the context of drug enforcement efforts. It is a continuous loop that ensures intelligence remains relevant and actionable, guiding the DEA's strategic and tactical responses to drug trafficking.

Financial investigation DEA: This area focuses on tracing the illicit financial gains derived from drug trafficking. DEA agents involved in financial investigations analyze bank records, identify shell corporations, and track the flow of money to disrupt the economic power of drug cartels, often leading to asset forfeiture and significant disruption of criminal operations.

Illicit drug market analysis: This involves studying the dynamics of illegal drug markets, including supply and demand, pricing, purity levels, and the emergence of new substances or trafficking trends. DEA intelligence analysts conduct this type of research to understand the evolving landscape of the drug trade and inform strategy development.

DEA source validation techniques: This refers to the rigorous methods employed by DEA agents to assess the reliability and accuracy of information obtained from human sources. It involves corroborating information from multiple sources, evaluating the source's access and motives, and understanding their track record to ensure the intelligence is credible and actionable.
